Dear Deputy Director O’Keefe:

Thank you for your letter of April 29, 2009 regarding (i) the placement of notification signs reading “Notice: Increased Train Traffic” at all Elgin, Joliet & Eastern Railway Company (EJ&E) grade crossings in Illinois, and (ii) IDOT participation in grade crossing diagnostic reviews at EJ&E grade crossings. I will address these two issues in turn.

With respect to the grade crossing signs, we respectfully disagree with your conclusion that the signs constitute “warning signs” under the Manual of Uniform Traffic Control Devices (MUTCD). As you will recall, our directive from the Surface Transportation Board (STB) was to erect “temporary notification signs or message boards, where warranted, in railroad right-of-way (“ROW”) at highway/rail at-grade crossings, clearly advising motorists of the increase in train traffic on affected rail line segments.” *Canadian National Ry. – Control – EJ&E*, Finance Docket 35087, Appendix A, VM 2, at 59 (STB Dec. 24, 2008) (emphasis added). The STB did not define these signs as warning signs, but rather signs that are designed to provide advice to the public. As you know, there is no provision in the MUTCD for signs with this message to be treated as either “warning signs” or “guide signs.” The signs are simply not contemplated by the MUTCD. Therefore, in determining how to prepare the signs, we reviewed the applicable provisions of the MUTCD and determined that they are most akin to “guide signs.” We stand by that conclusion.

You are correct that Section 2C of the MUTCD provides that warning signs “call attention to unexpected conditions on or adjacent to a highway or street and to situations that might not be readily apparent to road users.” However, that is not the

entirety of the definition of warning signs, for if it were, both "guide signs" and "warning signs" could fall under the definition of "warning signs." The MUTCD further states that warning signs are designed to "alert road users to conditions that might call for a reduction of speed or an action in the interest of safety and efficient traffic operations." Notification that additional trains may be operating in the area has no effect on the obligations of a motorist upon approaching a grade crossing. They must obey active warning devices, and determine it if is safe to proceed at crossings equipped with passive warning devices. The presence of one train a day over the crossing or one hundred does nothing to modify these duties.

Other portions of Section 2C of the MUTCD further emphasize that the signs required by the STB are not warning signs. For example, Section 2C.05 of the MUTCD addresses the placement of warning signs, and indicates that placement is an engineering judgment that is driven by the motorists' need for perception, identification (understanding), emotion (decision making), and volition (execution of decision). The signs at issue here do not call for a decision to be made by the motorist; as mentioned earlier, their duties are set by statute and are not affected by the number of trains using the crossing. Additionally, Table 2C-4 of the MUTCD provides that the minimum distance that any warning sign should be placed before the condition warned of is 225 feet, with longer distances for speeds over 20 mph. Because the EJ&E right of way is generally only 100 feet wide, we could not comply with both the STB's order to place the signs "in railroad right of way" and the MUTCD's distance guideline.

By contrast, the definition of "guide signs" includes the comment that they "help [motorists] along their way in the most simple, direct manner possible." This definition is most consistent with signs that provide a notification or advice, as required by the STB.

From a practical perspective, it is clear that the signs have accomplished their mission, which was to alert the motoring public of the potential for increased train traffic. Several news stories featured the new signs around the time that they were erected. Coupled with our media campaign (newspaper ads and internet notification) that accompanied placement of the signs, we believe the public has clearly been advised of the potential for more trains operating through these crossings.


With respect to the grade crossing diagnostic reviews, as you indicate, we provided IDOT with advance notice of the scheduling of such reviews. Given the large number of crossings to be reviewed, and the varying conditions presented by the crossings, it was impossible for us to either schedule or accurately predict a specific time for the review group to meet at specific crossings. Therefore, we did our best to provide information as to where the diagnostic review team would meet at the start of each day, and the direction they would work in reviewing crossings. As

information, the Illinois Commerce Commission has prepared preliminary comments based upon the diagnostic reviews, which I have enclosed. We are currently reviewing their comments and preparing a response, which we will share with you when it has been completed.

Dear Mr. Crader:

This letter serves as the Illinois Commerce Commission Rail Safety Section's (ICC) summary of recently completed meetings and field reviews with Canadian National Railway Company (CN) personnel concerning the highway-rail grade crossings located within the Illinois portion of the subject transaction. The field reviews are considered cursory in nature, since the majority of roadway authority representatives were not present at the reviews and the fact that most of the reviews occurred during non-peak vehicular traffic times.

As noted previously, certain aspects involved with the transaction will require CN to initiate formal proceedings before the Commission, including: crossings that will be grade separated; crossings that will be double-tracked (including potential sidings); crossings that will be expanded for pedestrian/multi-use purposes; pedestrian grade separations (either within or outside highway ROW); and, crossings that will require railroad warning device interconnection to adjacent highway traffic signals. In addition, certain aspects of the Surface Transportation Board's (STB) Decision regarding this transaction appear to necessitate the need for specific engineering studies to be performed at certain crossing locations, which has also been a past practice required by the Commission.

This office appreciates past information sharing on behalf of the CN, especially relating to proposed infrastructure upgrades and expansion that affect highway-rail grade crossings. We do, however, believe that a higher degree of transparency concerning the content of Voluntary Mitigation Agreements (VMA) between the CN and any public agency would be mutually beneficial to the CN and Commission as this process moves forward.
